Exposure may also lead to sensitivity to heat, itching, increased awareness of odor and taste, and liver damage. Iron compounds may cause vomiting, diarrhea, pink urine, black stool, and liver damage. May cause damage to the kidneys. Irritating to the respiratory tract, they may cause pulmonary fibrosis if dusts are inhaled.
